The Department has prepared a draft permit and has made a tentative determination, subject to public comment or other information, to approve an application to authorize the discharge of 1.8 million gallons per day (MGD) of treated municipal wastewater to the Hudson River from a secondary wastewater treatment plant located at the applicant's facility address located at 24 North Street, Stony Point. This is also a renewal, setting a new permit term.

Requests for a legislative (public statement) hearing must be sent in writing to the DEC contact person below by the comment deadline.
