

ADVERTISEMENT FOR BIDS

Receipt of Bids: Separate sealed bids on forms prepared by the Engineer will be received by the Town of Stony Point, Town Clerk, 74 E. Main Street, Stony Point, NY 10980 until **10 AM on November 26, 2024** for the **Town of Stony Point STP Headworks Project – ELECTRICAL CONTRACT** in accordance with Drawings, Specifications, and other Contract Documents prepared by Pitingaro & Doetsch Consulting Engineers P.C.

The project consists of the following:

- Coordinate with the Town of Stony Point STP Operator or his/her designatee.
- Furnish and install all wire and conduit to supply the proposed Headworks Building with 480 volt power from the Administrative Building.
- Furnish and install a disconnect, a transformer, a 3-phase distribution panel, a single phase distribution panel, and all wire and conduit.
- Furnish and install all wire and conduit to connect the proposed pump system including, but not limited to, the pumps, control panel and level sensors.
- Furnish and install all wire and conduit to connect the proposed bar screen system including, but not limited to, the bar screen, washer compactor, control panel and level sensors.
- Furnish and install all wire and conduit to connect the proposed grit system including, but not limited to, the paddle motor, grit pump and grit classifier, and control panel.
- Furnish and install all wire and conduit to connect the gas detection system, including but not limited to, the control panel, sensors, fans, louvers and alarm lights.
- Furnish and install all wire and conduit to connect any remaining miscellaneous equipment including, but not limited to, the crane gantry system, unit heaters, overhead door openers, louvers and fans.
- Furnish and install interior and exterior lighting, switches and receptacles.
- The Contractor shall provide all labor, supervision, materials, equipment, tools, utilities, and incidentals necessary to complete the Work as specified in the Technical Specifications and as shown on the Plans.
- This project is funded with New York State Financial Assistance and is subject to MWBE and SDVOB goals and additional required documentation.

Pre-Bid Meeting will be held at 10 AM on November 12, 2024 at the Town of Stony Point Sewage Treatment Plant, 24 North Street, Stony Point, NY 10980.

Bids will be publicly opened and read aloud at 10 AM on November 26, 2024, at the Town Hall, 74 East Main Street, Stony Point, NY 10980.

STATEMENT OF NON-COLLUSION

Bidders are required to execute a non-collusion bidding certificate pursuant to Section 103d of the General Municipal Law of the State of New York.

Attention of bidders is particularly called to the requirements relating to conditions of employment to be observed and minimum wage rates to be paid under the contract, Segregated Facilities, Section 109, and Executive Order 11246. Bidders are also required to comply with the provisions of Sections 291-299 of the Executive Law of the State of New York and all other applicable laws and regulations.

The Town of Stony Point hereby notifies all bidders that it will affirmatively insure that in regard to any Contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex or national origin in consideration for an award.
